Reference: Request to Amend ILP Process Plan and Schedule

Dear Mr. Murphy:

On October 31, 2019, Erie Boulevard Hydropower, LP (Erie) filed an Integrated Licensing Process (ILP) Relicensing Studies Progress Report #2 and Request to Modify the Process Plan and Schedule to Align with Study Plan Determination for the West Canada Creek Hydroelectric Project (West Canada Creek Project). As required by 18 C.F.R. 5.15(c)(1), the Initial Study Report (ISR) is due one year after issuance of the Commission's Study Plan Determination (SPD). The original process plan and schedule for the West Canada Creek Project anticipated that Commission staff would issue the SPD for the West Canada Creek Project on January 10, 2019, therefore requiring Erie to file the ISR on January 10, 2020. However, the SPD was not issued until March 7, 2019. While the SPD included a revised process plan that extended some deadlines, it did not change the due date for the ISR. As a result, Erie now requests a revision of the process plan to change the filing date of the ISR to March 7, 2020, to

¹ As required in the approved process plan, Erie filed a Revised Study Plan (RSP) on December 11, 2018, and comments on the RSP were due December 26, 2018. Based on the approved process plan, the Commission was scheduled to issue the SPD on January 10, 2019; however, due to the funding lapse at certain federal agencies between December 22, 2018, and January 25, 2019, Commission staff revised the process plan and issued the SPD on March 7, 2019, in order to allow affected agencies time to comment.

allow a full year following issuance of the SPD to conduct data analysis and prepare the study reports.²

In the interest of supporting the development of a more complete ISR and ensuring Erie has adequate time to complete data analysis and prepare the study reports, we are modifying the process plan to require filing of the ISR by March 7, 2020. The revised process plan is attached as Appendix A.
